Review comments for the paper entitled "Determinants of farmers' tree planting investment decision as a degraded landscape management strategy in the central highlands of Ethiopia" By B. Gessesse, W. Bewket and A. Bräuning.

General comments

The manuscript addressed one of the most essential topics in land degradation management options that aimed to recover different forms of the degraded landscapes and reverse the current situation of land degradation through adopting relevant and improved vegetative measures. The methodological approaches and statistical analysis employed in this study are appropriate. The major determinants of tree planting mea-



sures that are of great concern in the study area are adequately reflected by referring to reputable papers that are published by many scholars showing similar case studies carried out elsewhere. In the light of this, the paper provides significant contributions to scientific research and development, policy makers and implementors of farmers' tree planting investment as a strategy for management of land degradation so as to address wide ranges of environmental, economical and social issues in the study area. However, some of the following minor revisions are needed to be considered before publishing.

Specific comments âĂć The sentence in the abstract section, on p3246, line 11-17 is too long and better to split into two sentences. âĂć The last two sentences of the abstract section are needed to be rephrased in order to strongly illustrate the overall conclusions of the study. This could be achieved by using better connective words or by minimizing the connective words. âĂć In conclusion section, p3261 and p3262 the fourth, fifth and sixth sentences are needed to be coherently connected to convey the major conclusions of the study in a powerful manner.

Technical corrections

âĂć On p3246, line 23-24 rewrite the phrases in the sentences as "...... chemical and biological as well as anthropogenic" âĂć On p3247, line 4 the spelling for the citation "Turner and Mayer, 1994, as in line 4" shall be consistent with its corresponding one "Turner and Meyer, 1994" as found in the reference section. âĂć On p3247, line 11-20 the sentence " Considerable.......Teshome et al., 2014)" is too long and better to split it into at least two separate sentences. âĂć On p3248, line 24-29 the sentence "Although.......Bewket, 2007)" didn't appear to maintain the logical flow of the ideas raised in the preceding sentences, hence it is recommended to rewrite it up . âĂć On p3248, line 29 change the connective word "Besides" by " In relation to this" to improve the coherent flow of ideas and source for the information is also missing. Siting relevant references are needed. âĂć On p3249, line change the connective word "Thus" by "As a result". âĂć On p3249, line 5 rewrite the phrase as "The purpose of this study is to

Or the sentence can be maintained by changing the year of experiences from more than 20 years to more than 30 years. âĂć On p3256, line 15 rewrite the phrase as "...regression model as shown in Table 4....." âĂć On p3257, line 19 rewrite the phrase as ".....is decisions discussed as follows." âĂć On p3258, line 8 rewrite the phrase as "....influence in adopting land management technology" âĂć On p3258, line 21 rewrite the phrase as ".....productive labour force availability for tree growing..." âĂć On p3258, line 26-27 rewrite the phrase as ".....his/her participation in tree growing which would be increased....." âÅć On p3259. line 1 rewrite the phrase as

Note that you need to insert full stop/period at the end of the word "variables" so that the sequences of words can be broken into two sentences. aAć On p3260, line 4 rewrite the phrase as "......land-users' perception..." âĂć On p3260, line 5-6 rewrite the phrase as ".....affirmative implication on the likelihood of households participating in tree arowina." âĂć On p3261, line 12-13 rewrite the phrase as "Thus, further investigation should be needed to examine these cases to come across conclusive arguments." aĂć On p3261, line 21 rewrite the phrase as "The study showed that, the likelihood of household size," aĂć On p3261, line 26 rewrite the phrase as "Due to these facts, the study provides relevant policy......" aÅć On p3261 (line 27) and p3262 (line 1) rewrite the phrase as "Overall, it can be concluded that, land resource management."
