I appreciate the time and effort by reviewer 1 to correct my paper and I will strive to address all of his concerns to the best of my knowledge. I have organized my answers to follow each question individually and the changes in manuscript are given by page and line numbers so that the reviewer can find them in the attached word file that will eventually make my revised manuscript.

I hope, I have answered all the questions but please let me know if you have more questions to be answered or discussed.

**Question 1.** There are works in literature on optimal focusing of drill bit signals only from geophone data to create a reference trace (for example as proposed by Haldorsen et al., 1995, Geophysics 60, 978-997). The approach followed by authors is different in my understanding as they use only one neargeophone reference trace. For completeness of the work authors should consider and comment also this approach.

## Answer:

I mentioned this method in the introduction (page 4, lines 18-26). Their method requires large offsets on the surface in order to obtain moveout separation required in focusing analysis. Our dataset has very short offset of about 180 m on East side and 90m on the West side of well BH001.

**Question 2.** Could you please specify better which type of bit is used in the experiments? I understand a Hammer bit with periodic hammering action (e.g., as in figure 3). Also roller bits have a percussive action. Please describe better

### Answer:

The drilling method was Reverse Circulation (RC). I have added information about the mechanism in part 2 (page 5, lines 10-13), passive seismic survey acquisition.

**Question 3.** Just a comment on the analogy with Vibroseis sweep. The vibroseis sweep typically is designed to contain, by definition and construction, 'non repeatable' components. In figure 3 you show a very repeatable in time hammering signal. So your statement at line 13 of page 2 seems not appropriate, even if the use is similar. May be after deconvolution. I suggest to rephrase in some way

# Answer:

I added a reference for this ((Poletto and Miranda, 2004) on page 2, line 13. I have seen this at page 291 of that book.

**Question 4.** Comment for Figure 3a. I understand that this is correlation and stacking. However I see only causal signal parts (I suggest to specify the zero of cross-correlation time). So, may be I'm wrong, but I would interpret that this is correlation and stacking and also Deconvolution applied. Please specify better when you correlate, stack (I assume without shifts) and deconvolve the data in the example

## Answer:

I think you mean Figure 4a as figure 3a shows raw data. Yes, the traces in fig. 4a are crossc orrelated and deconvolved in one combined process called interferometry by deconvolution (Vasconcelos and Snieder, 2008). I have added more description in the paper (page 10, lines 11-16).

**Question 5.** Again comment for Figure 3a. The data quality is good. However not clear the interval of stacking. Only few meters of bit descent, or all the data recorded along all the drilled interval? This is a very important information, because you can focus different events. Please introduce details

### Answer:

Data recorded for the entire well (0-70 m) is cross correlated. However, intervals as small as a few meters could produce the same results but a little noisier.

**Question 6.** In relation to previous comment, I'm wondering if you want to focus the rig as a source or focus the bit as a source (as I would understand from Fig 1). It strongly depends on stacking of stationary and non-stationary components, as chosen by you. Both can be valid, however please specify

### Answer:

Here we are using the bit signal as the source. We isolated the bit signal by FK filtering as demonstrated in Figure 3. The bit location in the borehole are in the stationary phase position and the corsscorrelations can be stacked to build the virtual shots. We confirmed this in Fig. 4 by making a comparison with active data.

Question 7. In the work of Poletto et al. 2011 ("Drill-bit SWD and seismic interferometry for imaging around geothermal wells" SEG San Antonio Expanded Abstracts, 4319-4324), a similar approach and use of the drill bit source is shown (in this case with pilot data). However the main point is if the coverage illumination for stationary interferometry conditions is met. This, when you want to recover by interferometry stacking the surface related multiples to extend the illumination. In Poletto et al (2011) for example the extension is shown, with merging of conventional drill bit SWD and interferometric drill bit SWD data in a well experiment. However in this case the retrieval of the interferometric drill bit signal (only by stacking before migration) does not depend on the subsurface model (as was verified in this work as an approximetion.

Answer: (sorry if I didn't understand the question very well)

Unfortunately we didn't have pilot accelerometer recordings in our experiment to convert drill bit data to IVSP dataset and use it to verify our inerferometric image. However, we could still produce virtual shots on the surface by interferometry and migrate the results as we do with active source data and compare the results with surface seismic migration results.

**Question 8.** The stationary condition, indeed is not needed if you use the Cross-correlogram migration. However in this case you have to use a subsurface model. In this case, depending on the interferometric approach, you are dependent on the model estimation, unlike the virtual source. If you apply in complex areas this is something you try to recover, I would image. So, comments on these aspects should be given

### Answer:

We used Kirchhoff migration of virtual data using a simple velocity model. We already showed that the bit signals are indeed in their stationary phase positions in Figure 4a. One would carry out a focusing and velocity analysis if enough offset were available and moveouts were significant for more accurate velocity estimation and image construction. Here, the offsets are very limited and such analysis are not an option.

**Answer:** I added the disadvantages of using interferometric migration to the introduction (page 4, line 5-11).

Although there is no separate section for preconditioning of the data, these steps have been discussed throughout

the paper when the opportunity arises. I added a discussion related to the need for larger offset-to-depth ratios for

focusing analysis and source signature estimation (page 4, line 18-26). I added a description of drilling mechanism

and the bit type (page 4, lines 9-12). I added a part reasoning how signal-to-noise ratio was improved by larger

depth and geology for the well under the study (page 14, line 11-13). The comparison with other SWD experiments

is not straightforward as here we are dealing with near-surface conditions and shallow drilling depths. Offset is

also very short, drilling method is different and there is no pilot trace recorded.

**Answer:** see Table 1 on page 6.

Analysis of seismic while drilling data.

**Answer:** I reworded this part (page 10, lines 8-10). This was to say that the well (sources in the well) have to be

in-line with the seismic line in order to meet the stationary source requirements of the IVSP interferometry as

shown in Fig. 1. I have given references for this in the text. Please see also figure 2 in Schuster (2014) for more

detailed explanation.

Question, Regarding figure 4, please make a statement about the signal-to-noise ratio of the crosscorrelated and

stacked traces vs. active source traces.

**Answer:** I added a statement that passive shot has obtained a signal to noise ratio comparable to that of active

shot (page 10, lines 17-18).

Question, I assume the seismograms are trace normalized. The shear waves of the correlated traces seems to be

stronger than in the active seismic survey. What are possible reasons for this?

**Answer:** The drill bit rotation generates lots of shear waves energy.

Interferometry and virtual source migration

**Question,** The migrated images of the virtual shots and the corresponding active seismic shots in figure 5 reveal

different depths of reflections. What kind of velocity model was used to image the active seismic shots? What are the

differences to the 3 layer velocity model used for imaging the virtual shots?

**Answer:** The stacking velocity (0,1640) and (1000, 2500) was used by processing team to produce stack volume

where first value is time in ms and the second value is the velocity. The same function was used to migrate them

in time using 3D post-stack Kirchhoff time migration algorithm. Using exactly the same values as in 3D seismic

processing will result in non-coherent events and low signal to noise ratio of the passive image. On the other hand,

velocity model in Figure 5 results in greater event coherency and larger signal to noise ratio in the migrated image

than using simpler 3D survey velocity function. This velocity (Figure 5) was also used to depth convert 3D time

volume. The mismatch in depth would be expected as a result of slight differences in velocities. Please note, I

have reinterpreted the horizons (1-4) in figure 5 (d) and (e).

Question, The frequencies of the drill bit noise image is lower than that of the active shot image. Please make a

statement on this and show average frequency spectrum for both images for comparison. This would allow the readers

to get an impression on the resolution of both data sets.

**Answer:** I added two spectrums in figure 5 and an statement to text (page 12, line 15-19).

**Question,** Does any of these reflectors are corresponds to the target reflectors mentioned in chapter introduction?

**Answer:** Unfortunately, the interpretation cannot be published based on the confidentiality agreement

with BHP minerals as this relates to a new Iron ore prospect in the region.

**Summary and conclusions** 

Question, under point 3 of the summary it is mentioned that drilling deeper wells leads to a large signal-to noise ratio

in the final image. I have some doubts in this general statement because on the one hand the number stacked events

increase but on the other hand the signal to noise ratio of the drill bit events are getting lower because of the longer

travel path of the waves.

# Drill bit noise imaging without pilot trace, a near surface interferometry example

**Abstract.** Acoustic energy emitted by drill bit can be recorded by geophones on the surface and processed for an image of the subsurface using seismic interferometry methods. Pilot sensors record bit signal on the drill rig and play an important role in processing geophone traces for the image. When pilot traces are not available, traces of the nearest geophone to the rig may be used in deconvolution and crosscorrelation of data but extra signal processing efforts are required to reduce the effect of source signature on crosscorrelation results. In this study, we use seismic interferometry method to image the shallow subsurface beneath a 2D geophone array by converting geophones to virtual sources. As there is no pilot signal available for this survey, we use nearest geophone trace for pilot crosscorrelation and pilot deconvolution. We modify the spectrum of pilot crosscorrelation and deconvolution results so that the effect of source function on virtual data is minimized. We then migrate the virtual shots and compare the results of interferometric imaging with the available image from 3D (active source) survey and assess the efficiency of our approach. We show that drill bit noise data can be used to generate a reasonably accurate image of the subsurface even in the absence of pilot recordings but the results should be checked for appearance of virtual multiples and depth inconsistencies that are caused by errors in the migration velocity.

### 0 1 Introduction

A significant <u>level</u> of acoustic energy generated by the drill bit hammering action at the bottom of a borehole is transferred into the geological formations surrounding the borehole and can be recorded by an array of geophones on the surface and processed for a subsurface image under the receiver array. Seismic while drilling records can be either transformed to inverse vertical seismic profiling (IVSP) data and imaged following standard IVSP migration methods (Poletto and Miranda, 2004) or redatumed to surface by interferometry to form virtual surface records and then migrated for an image (Schuster, 2009; Wapenaar et al., 2010a; Wapenaar et al., 2010b; Schuster, 2014).

Borehole imaging methods either place their energy source in the borehole with the receivers on the surface (i.e. IVSP methods) or place the receivers in the borehole and the source on the surface (i.e. VSP methods) to reduce wave's propagation path to only one leg. This makes these methods less vulnerable to near surface heterogeneity and to obtain wider frequency bandwidth as a result of <a href="mailto:smaller energy absorption">smaller energy absorption</a> compared to reflection surveys where both the source and the receivers are positioned

on the surface. Interferometry transfers borehole sources or the receivers to the surface and forms virtual shot records that gives the methods a much wider subsurface coverage comparable to that of surface seismic methods. Therefore, drill bit noise imaging using seismic interferometry can be seen superior to surface seismic imaging experiments especially in areas where near surface velocity complexity results in poor quality reflection data. Nevertheless, primary objective behind using passive seismic methods such as drill bit noise imaging is to obtain similar data to active source methods by spending less. This is particularly important in geotechnical investigations where the imaging zone is usually small and often shallow and deploying expensive active source acquisition equipment is not economically justified. Additionally, near surface methods and geotechnical investigations are commonly implemented by drilling several shallow boreholes which can provide enough acoustic energy for imaging the subsurface using passive seismic methods. If the cost objective is met in practice by an efficient data acquisition and processing approach, using seismic methods can become more affordable and hence more widely used by smaller mineral exploration and geotechnical investigation companies who were unable to use it before.

In drill bit noise imaging, the continuous hammering action of the bit in the borehole generates a waveform that is more similar to that of a vibrosies sweep in active source seismic surveys (Poletto and Miranda, 2004). Similar to the role of a pilot sensor in a vibrator machine, an accelerometer is planted on the drill stem or the rig (swivel) to continuously record the bit signal as the drilling operation progresses (Rector and Hardage, 1992). This signal, the pilot trace is then crosscorrelated with the raw geophone recordings over a window of several tens of seconds to produce a seismogram with usually identifiable seismic events. In practice, seismic recordings associated with a short drilling interval are crosscorrelated with the pilot signal and stacked to increase signal to noise ratio. The autocorrelation of the pilot signal is then deconvolved from crosscorrelated seismograms to produce an initial shot record that can represent an impulsive source in depth (Vasconcelos and Snieder, 2008). These seismograms are then used to produce virtual shot records on the surface following the principles of seismic interferometry or further corrected for differences in time to generate IVSP data. Crosscorrelation of pilot signal with the geophone recordings results in seismic events with traveltimes that are relative to pilot sensor. To derive shot records that correspond to the bit at its zero excitation time, P-wave travel time along the drill string is added to crosscorrelated seismograms in a step known as pilot delay correction (Poletto and Miranda, 2004). Pilot delay corrected shot records can then be regarded as equivalent to IVSP data and processed accordingly for a subsurface image.

Seismic interferometry states that crosscorrelation of data recorded by two receivers, transforms these data into traces that would be recorded by one receiver acting as source. Wapenaar et al. (2010a) present an example for converting a seismometer station to a virtual source of Rayleigh waves by crosscorrelating its trace with the traces of 400 other seismometers (USArray stations) that cover the entire state of California. In that study, three years of ambient noise recordings were crosscorrelated to generate the virtual source record. In the borehole, first order VSP ghosts can be transformed into virtual primary reflection events through interferometry (Schuster, 2014). Figure 1, illustrates the concept of VSP to surface seismic interferometric transformation schematically.

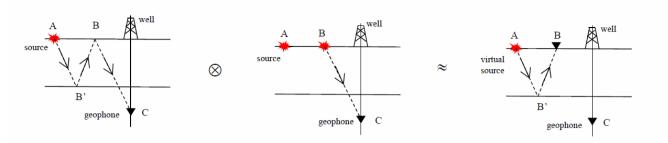


Figure 1. Interferometric transformation of VSP data to surface seismic recordings.

In Fig. 1, the phase associated with common raypath (BC) for sources A and B, is cancelled after crosscorrelation of traces recorded by downhole geophone C. <u>In practice, several geophone recordings in the borehole are stacked in order to cancel out the waveform related to common ray path BC.</u> Equation (1) describes the relationship between various modes in Fig. 1 for interferometric VSP to surface seismic transformation:

The first term in the left side of Eq. (1),  $d(B,t \mid A)$ , describes the trace recorded by the virtual geophone at location B from the virtual source at A. The second term in the left side of Eq. (1), c(t), represents the autocorrelation of the source wavelet in A. Right side of the Eq. (1) presents sum of the crosscorrelation of the wavefields recorded by the borehole geophones at C,  $d(C,t \mid A)$  and  $d(C,t \mid B)$  from the sources at A and B, respectively. In Eq. (1),  $\otimes$  stands for crosscorrelation operator.

Equation (1) is equally valid for IVSP acquisition setup (reciprocity principle) where the stacking of crosscorrelated traces takes place over a number of sources in the borehole.

Yu and Schuster (2006) present a workflow to migrate virtual source data (ghost-direct wave migration) generated by crosscorrelation and stacking of IVSP data that can also be applied to drill bit passive measurements on the surface. To produce virtual sources, IVSP data are first separated into upgoing and downgoing waves followed by source wavelet deconvolution from downgoing arrivals. Next, direct arrivals are windowed out from the downgoing-deconvolved dataset and are crosscorrelated with the remaining part in the downgoing dataset. This will assure that virtual multiples are not created by correlating the traces. Finally, the results of crosscorrelations for all the source positions in the borehole are summed to generate virtual source traces. Virtual source data can then be migrated by diffraction stack migration algorithm.

Ghost-direct (interferometric) migration of IVSP data has many advantages over standard IVSP imaging methods that makes it particularly desirable for drill bit noise imaging where the drill bit position in depth is hard to be linked to recorded data. In interferometric migration, source locations in the borehole need not to be known as a priori information as the crosscorrelated

seismograms are stacked independent of source depths. Furthermore, source related statics does not influence the interferometric migration. This allows us to dismiss pilot delay estimation and correction step that was necessary in standard IVSP imaging. Also, in contrast to standard migration methods, interferometric migration can be applied to non-impulsive source wavelets such as those encountered in drill bit imaging (Yu and Schuster, 2006). Finally, as stated earlier, interferometric migration creates a wider subsurface illumination zone than standard VSP migration methods. The main disadvantage of the interferometric migration of drill bit data is the introduction of virtual multiples in the final image as a result of inefficient direct wave and ghost separation before crosscorrelation. To make the matter even worse, windowing out the ghost arrivals from direct P-wave event may not be an option in drill bit imaging if the pilot deconvolution has not been effective in converting the bit signal to an impulse. In such cases, full trace recording is crosscorrelated with the traces of other geophones to produce virtual shot records but the migration results must be scrutinized for the existence of coherent virtual multiples.

Poletto et al. (2010) analyse the results of interferometric drill bit imaging for a roller cone bit drilling experiment with and without using a pilot trace. For the case where no pilot measurement is used, the standard interferometry, they consider the geophone trace at the location of virtual source as the reference trace and crosscorrelate it with the traces of other geophones along the seismic line while deconvolving the autocorrelation of this trace (as source signal) in a process called interferometry by deconvolutiom (Vasconcelos and Snieder, 2008). They acknowledge that some uncorrelated noise such as drill yard noise that could be minimized by pilot crosscorrelation may enter the results of standard interferometry and that a much better deconvolution could be obtained if pilot measurements were used. The focusing capability of large arrays of geophones on the surface can also be used to obtain the drill bit signal and the deconvolution filter. Haldorsen et al. (1994) and Haldorsen et al. (1995) describe this approach in four processing steps. First, apply focusing analysis to find the velocity that focuses most of the energy back at the bit location. This velocity gives the first estimate of moveout times. Second, find and apply a deconvolution filter that best spikes moveout corrected traces in step one. Third, correct the moveout times by picking first break times on the deconvolved traces and repeat step two. Finally, migrate deconvolved data using the generalized Radon transform (GRT) migration algorithm described in Miller et al. (1987). This method nevertheless requires large source to receiver offset measurements on the surface in order to effectively use event separation in time (moveout) for velocity estimation.

In this study, we follow the interferometry approach proposed by Poletto et al. (2010) for the case where there is no pilot signal measurements available. We evaluate the potential of a 3D seismic while drilling dataset for subsurface imaging by comparing the passive migration results along a 2D subset line with the images of an active source seismic survey. As pilot trace recordings on either drill stem or the rig (the swivel) were unavailable in this survey, we used traces of nearest geophone to the rig as an approximation to drill bit source function and used these traces to deconvolve autocorrelation of source function from crosscorrelated traces in virtual shot records. We then migrated the virtual shot records in depth using a simple velocity model and assessed the results against active source seismic image. We will discuss the results of this study and propose our recommendations and conclusions at the end of this paper.

## 2 Passive seismic survey acquisition

In June 2017, Curtin University acquired two-sets of 3D seismic surveys for BHP Minerals Australia over an iron ore prospect on the northern flank of the Fortescue Valley in the Pilbara region of Western Australia. The geology consists of Marra Mamba Iron Formation slowly dipping to the south into the Fortescue Valley. The area is covered with tertiary detrital sediments of varying thickness and composition. The aim of the seismic investigation was to image the shallow detrital-bedrock contact, image the major shale unit at the base of the iron formation and identify major ore controlling structures.

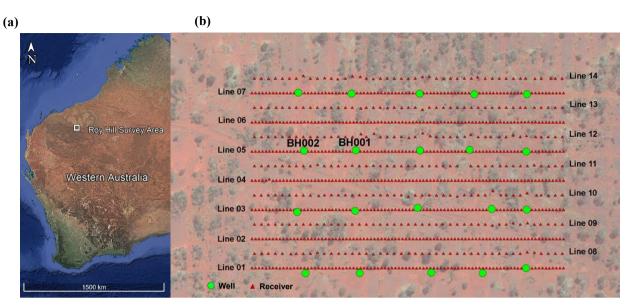


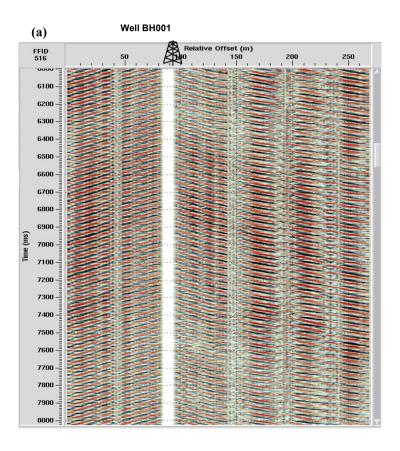
Figure 2. (a) Survey area in Western Australia and (b) receiver line geometry and the location of exploration wells in the pattern survey.

The two surveys share a common receiver spread on the surface with a weight drop mechanism being used as the seismic energy source in the active survey. The passive survey was recorded simultaneously with the drilling of 19 exploration wells on a 50 m by 50 m pattern in the survey area and comprised only vertical component geophone recordings. Drillers used reverse circulation (RC) method to drill all the wells in the survey area. The drilling mechanism in RC methods often comprises a pneumatic reciprocating piston known as hammer, a tungsten-steel drill bit that crushes the rock and a dual-wall drill rod that transfers rock cuttings to the surface using high pressure air. Figure 2 illustrates the passive survey geometry and the location of wells in the survey area. Receivers are spread along 14 East-West oriented lines at 12.5 m line interval with alternating 96 and 49 receiver stations along receiver lines 1-7 and 8-14, respectively. Geophone spacing is 3 m and 6 m over lines 1-7 and 8-14, respectively. Only stations 1 to 90 along lines 1-7 and 1 to 45 along lines 8-14 were selected for this study. The aim of passive seismic (while drilling) exercise was to determine if passive seismic data can be processed and imaged to provide a comparable dataset to the active seismic source dataset.

Passive survey data were recorded continuously by <u>Sercel's</u> autonomous <u>geophone unite</u> nodes (<u>Sercel's unite</u>) over the course of drilling and were stored in 7359 files with each file containing 30 seconds of drilling signals. Each field file records <u>945</u> <u>975</u> traces and each trace contains 15001 samples at 2 ms sampling rate. <u>Table 1</u>, <u>provides a summary of the acquisition parameters for the passive survey at Roy Hill.</u>

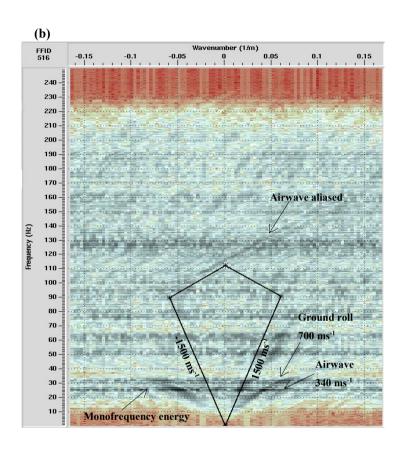

## 3 Analysis of seismic while drilling data

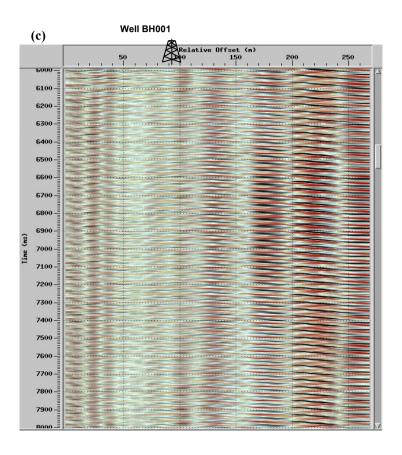


Figure 3. (a) 2 seconds of passive seismic data recorded along receiver line 5 and while drilling well BH001. (b) the same data as in (a) shown in frequency-wavenumber (FK) domain. Note aliased airwave and appearance of strong monofrequency energy in (b). (c) shows data in (a) after the application of FK filter where the energy outside the polygon is rejected. Note the seismograms in (c) are dominated by bit related monofrequency energy seen in (b).

Processing seismic while drilling data for the purpose of virtual shot generation using interferometry methods requires isolating drill bit generated (P-wave) sound from other types of seismic waves that are recorded by geophones on the surface. Figure 3 demonstrates 2 seconds of raw data in both time-offset and frequency-wavenumber (FK) domains that were recorded by geophones along the receiver line 5 and while well BH001 was being drilled. Trace amplitudes in Fig. 3, (a) were normalized and gained before FK analysis in Figure 3 (b). Traces recorded by geophones over the drill pad, white stripe in Fig. 3 (a), were muted before further processing.

In Fig. 3, (a) surface waves (ground roll) can be easily identified as the high energy linear event dipping in opposite directions at either sides of the well. In Fig. 3, (b) ground roll can be identified as linear events with velocity of ±700 ms<sup>-1</sup> and with seismic energy in the frequency range of up to 30 Hz. The noise created by wind can also be identified in Fig. 3, (b) as a linear event that is aliased at near 60 Hz with velocity of 340 ms<sup>-1</sup>. Flat events with high energy in Fig. 3, (b) correspond to drilling operation and energy generated by the hammering action of the bit. These events have large energy and appear at random

frequency bands in the data. After reviewing several shot records in the survey, we decided to remove the linear noise with apparent velocity under 1500 ms<sup>-1</sup> and frequency over 110 Hz. This was implemented by applying the FK filter specified by the polygon in Fig. 3, (b). Figure 3, (c) shows the data in Fig. 3, (a) after applying the FK filter. Monochromatic character observed in Fig. 3, (c) is caused by the flat and high energy modes retained inside the polygon in Fig. 3, (b).

Before we start crosscorrelating bit data for interferometry migration, we can check the potential of using this dataset for virtual shot generation on the surface by crosscorrelating the raw gathers and comparing the results with active source data. We will crosscorrelate raw geophone recordings for one of the wells and produce a virtual shot record at the location of that well and compare it with the raw shot record extracted from the active source survey at the location of virtual shot. Note that in our analysis, we only select a well that is inline with the receiver line to meet the stationary source positioning requirement of the direct wave interferometry (Roux et al., 2005; Campillo and Roux, 2014; Schuster, 2014).

Figure 4, (a) shows the virtual shot created by crosscorrelating-deconvolving and stacking (interferometry by deconvolution) of raw data recorded while well BH002 was being drilled. For each field record, nearest geophone trace to well BH002 was taken as the source signal and was crosscorrelated with the rest of the traces along line 5 while being simultaneously deconvolved from the crosscorrelated traces. This process is then repeated for all the recorded files from surface to the bottom of the well and the results are stacked to produce Fig. 4 (a). Note that in in Fig. 4 (a), the causal time in crosscorrelation starts at 30000 ms but energy arrives at about 50 ms earlier. Figure 4, (b) shows the traces of the shot record taken from the active source 3D survey with source position at well BH002 and receivers confined to line 5. The passive shot has acquired a signal to noise ratio proportional to that of active source measurements and high energy ground roll, refracted P-waves and shear waves have all been reproduced by the interferometry process.

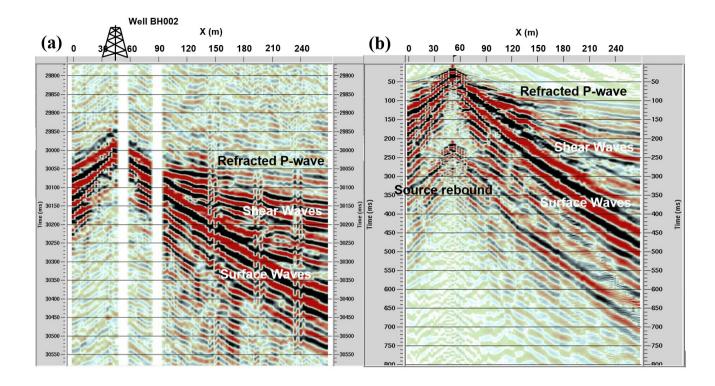


Figure 4. (a) <u>The</u> results of <u>interferometry by deconvolution of</u> the raw data <u>at the location of well BH002</u>, against the active source gather recorded <u>at the same location</u> (b). Note the weight drop source rebound <u>energy recorded</u> in (b).

### 4 Interferometry and virtual source migration

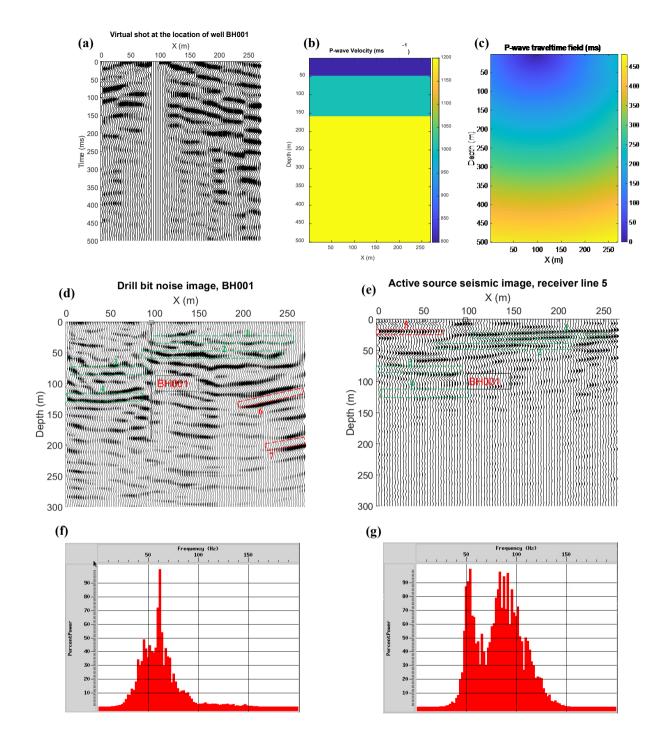

In this step, we will first crosscorrelate bit data isolated by FK filtering with the trace of the geophone at the nearest position to well to produce initial seismograms. We will then follow the approach proposed by Poletto et al. (2010) for standard interferometry of drill bit noise data and interferometry by deconvolution (Vasconcelos and Snieder, 2008) to produce virtual shot records from the seismograms. In the final step, we will migrate the shots in depth using a three layer velocity model. Figure 5, (a) shows the traces of virtual source generated from bit noise (Fig. 3, (c)) at the location of well BH001 at X=96 m. The traces of virtual source were simultaneously deconvolved by the reference trace's autocorrelation during the crosscorrelation operation. Figure 5, (b) shows the three layer velocity model used to migrate virtual shot records to depth domain. For each grid point in the model, P-wave reflection traveltimes where computed by ray tracing from the location of the virtual source on the surface to the image point and back to the receivers on the surface. Figure, 5 (c) shows P-wave traveltime field computed by ray tracing for the migration of virtual source shown in (a). Figure 5, (d) shows the results of Kirchhoff migration for virtual shots generated by interferometry of passive data recorded along line 5 and while drilling well

BH001. Figure 5, (e) shows the seismic profile collocated with line 5 that was extracted from the depth converted active source 3D survey. Similar velocities as in Fig. 5, (b) were used to depth convert surface seismic survey. Figure 5, (f) and (g) show the normalized power spectrum of the passive and active source seismic profiles in (d) and (e), respectively.

Making a comparison between Figures 5, (d) and (e), in spite of using only a geophone trace for pilot crosscorrelation and deconvolution, geological character of the subsurface under the receiver line 5 has been successfully recovered in the first 200 minterval. Four main seismic events (1 to 4) are highlighted in green boxes in Fig. 5, (d). Events with similar character can be identified in Fig. 5, (e) that are also highlighted and numbered for comparison. There is however, a slight mismatch in depth between the highlighted events 1 to 4 in two figures that is more likely caused by using a three layer (flat) velocity model in migration that is not capturing all the details of near surface heterogeneity. We refrained using velocity model derived in 3D active source seismic processing as it resulted in less coherent horizons and lower signal to noise ratio in the passive image. Event 5, a strong peak does not appear in interferometric image and events 6 and 7 do not show up in active source image. Events 6 and 7 and many more deeper events may represent virtual multiples as we did not separate and crosscorrelate direct wave with the later ghost arrivals as described in IVSP ghost-direct migration. This was mainly due to unavailability of pilot recordings and inadequate pilot deconvolution in this study. Incomplete pilot deconvolution results in nonimpulsive direct arrivals that cannot be separated from associated ghost arrivals for more efficient ghost-direct crosscorrelation.

Furthermore, we observe noticeable difference in vertical resolution between passive image and active source image in Fig 5, (d) and (e). This difference can be well explained by the distribution of passive and active source seismic energy in frequency domain shown in (f) and (g). Passive energy drops significantly (<20 %) over 70 Hz while this value is about 120 Hz for active source data.

## 5 Summary and conclusions

We recorded a 3D passive dataset using <u>vertical</u> component geophone nodes and while drilling several shallow exploration wells over a small iron ore prospect in Pilbara region of Western Australia. We also recorded a second 3D survey in the same area using weight drop sources with identical receiver setup to that of passive survey. The objective was to check the accuracy of interferometric migration by comparing the results with the results of active source migration. To reveal signal generated by the bit, we removed the strong linear noise (e.g. rig generated surface waves) by applying a filter in the FK domain. Here, we only used while drilling data recorded along line 5 for well BH001 to produce interferometric shots on the surface. Well BH001 is the deepest well in the survey area (bottom at 189 m) and this <u>has</u> enhanced <u>signal to noise ratio</u> of <u>the</u> crosscorrelation <u>result</u> by stacking more traces. This is intuitive as well BH001 penetrates into the deeper strata it faces harder <u>rock material with longer drilling time that leads to more acoustic energy being emitted into the surrounding formations and hence stronger signal being recorded by geophones on the surface.</u>

If the pilot trace recording is not available, then the geophone recording of the closest station to the rig can be used as a rough approximation to source signal. As pilot signals were not recorded for this survey, we used the recording of the nearest geophone to well BH001 for pilot crosscorrelation and pilot deconvolution. This however, impacted both the pilot crosscorrelation and pilot deconvolution by producing seismograms with more complex shape and non-impulsive appearance. To minimize the effect of suboptimal deconvolution we reshaped the spectra of the traces during deconvolution. This process significantly reduced monochromatic character of the output seismograms before crosscorrelation and generating virtual shots. We then produced virtual sources on the surface by crosscorrelating the trace at the position of the virtual source, the reference trace with the rest of the traces along line 5. In this process, every geophone on the seismic line is turned into a virtual source while every other geophone becomes a virtual receiver for that source. To migrate virtual shot gathers, we used a three layer P-wave velocity model with values close to those used in active seismic depth conversion. We generated a time field for each source by ray tracing in the model and used these time values to migrate the shots. Comparing the image derived from drill bit interferometry with the active source image verifies that despite the introduction of some strong coherent noise (virtual multiples) in the interferometric image (events 6 and 7 in Fig. 5, (d)) that is caused by inadequate pilot deconvolution and crosscorrelation, main subsurface structure has been successfully recovered by bit noise migration. There is however a slight mismatch in depth between similar events on two images that is caused by using too smooth and simple velocity structure in the migration.

Based on the results of this study, we summarize the following important conclusions in drill bit noise imaging without a pilot signal:

- 1. Drill bit noise can be recorded passively and used to produce a reasonably accurate image of the subsurface using interferometry methods even in the absence of rig pilot measurements.
- 2. The results of drill bit interferometric imaging with no pilot measurements should nonetheless be checked for virtual multiples and inconsistencies in depth.
- 3. Drilling deeper wells leads to larger signal to noise ratio in the final image as more data enter the stacking process described by the interferometry equation. This might be overruled however, by the length of wave's travel path (also spherical divergence) and the level of energy absorption in the surrounding rocks.
- 4. Longer receiver lines will enable us to carry out the migration in common offset domain where an accurate estimate of subsurface velocity can be obtained and used for a better migration.
- 4.5. Larger offsets to depth ratios will also enable us to carry out a more effective focusing analysis on geophone data where an active seismic source can be simulated at the bit location with an estimate of normal moveout (NMO) velocity that can be used in the migration.

Finally, for each field case, various type of passive signals and the effect of earth's near surface velocity heterogeneity on drill bit noise should be fully understood and accounted for in preprocessing step before one can apply routine seismic while drilling and interferometry algorithms to these data and offer the results as an alternative solution to active source seismic surveys.
